

NOTICE OF ELECTION

STATE OF SOUTH CAROLINA

COUNTY OF HORRY

A Republican Presidential Preference Primary will be held on Saturday, February 20, 2016. A Democratic Presidential Preference Primary will be held on Saturday, February 27, 2016. These primaries will be conducted in the polling places listed in this notice.

Voters may participate in only one party's presidential preference primary. The deadline to register to vote and be eligible to vote in either Presidential Preference Primary is January 27, 2016.

The polling place locations for some precincts may be combined with others for the primaries as allowed by law. The polls will be open from 7:00 a.m. until 7:00 p.m. at the polling places designated below. These primaries will be held under the rules for providing Photo ID at the polling place. Voters will be asked to provide one of the following Photo IDs at their polling place.

- S.C. Driver's License
- ID Card issued by S.C. Department of Motor Vehicles
- S.C. Voter Registration Card with Photo
- Federal Military ID
- U.S. Passport

If you have one of these ID's, you are ready to vote. Voters should remember to bring one of these photo ID's with them to the polling place. Voters without Photo ID can get one free of charge from the Department of Motor Vehicles or their county voter registration and elections office. Voters who encounter an obstacle to getting a Photo ID should bring their paper voter registration card without a photo with them to their polling place. These voters can then sign an affidavit swearing to their identity and to their obstacle to obtaining a Photo ID and vote a provisional ballot. This ballot will count unless the county election board has grounds to believe the affidavit is false.
