- \_\_\_ 1. Provided evidence the food vending cart meets the size and dimensional requirements of the ordinance.
- \_\_\_ 2. The applicant has submitted a site plan showing the proposed location of the vending operation on the plan. The Zoning Administrator will find that the proposed operation complies with all applicable provisions of this Section, and that the proposed operation will not adversely affect the traffic accessibility, or health and public safety before a permit is issued.
- \_\_\_ 3. Provided evidence of compliance with health and fire regulations: a certificate of inspection or compliance as required by applicable health regulations (DHEC) and evidence of compliance with the fire code.
- \_\_\_ 4. The vending cart meets a 25' front setback, and the side and rear setback requirements of its underlying zoning district.
- \_\_\_ 5. There is a principal structure and business on site.
- \_\_\_ 6. A minimum of two (2) parking spaces are provided in addition to the minimum parking required for the principal business.
- \_\_\_ 7. The cart is located on a parcel with no less than a paved thirty feet (30 ft.) driveway throat length.
- \_\_\_ 8. The cart is not located within seventy-five (75) feet of the principal public entrance to any food service business not owned by the vendor or property owner, which sells merchandise which is approved for sale in this ordinance (unless the adjacent food service business owner has provided a legal affidavit agreeing to a lesser distance).
- \_\_\_ 9. The cart is not within ten (10) feet of an entranceway to any business open to the public.
- \_\_\_ 10. A letter and/or copy of an official lease agreement from the property owner to vend on the subject parcel and a copy of the property owner's business license are provided. If applicable, the vendor has provided a copy of the approved county hospitality tax application and a State sales tax number to the Zoning Administrator.
- \_\_\_ 11. I have read and understood the permitted merchandise, prohibited conduct requirements, and violations sections as provided.

I hereby acknowledge by signature below, that the proposed **Food Vending** business satisfies the definition of a **Food Vending Cart** and meets the requirements for Food Vending as listed above and fully explained in **Section 521** of the Horry County Zoning Ordinance, which is provided attached to this application. I understand that the County may revoke zoning compliance for this **Food Vending** permit if the business is found to be in violation of these requirements.
