



Public Notice Horry County Housing & Community Development Consolidated Plan

Horry County is accepting comments from April 5, 2008 to May 5, 2008 on the draft of its five-year consolidated plan. The consolidated plan is the application for federal Community Development Block Grant (CDBG) funding and consists of a strategy to address the housing, homeless, and community development needs of our county. The plan also includes an Annual Action Plan that identifies the actions to be taken in the coming year to implement the identified strategies. Horry County will receive a total of \$1,497,929 for the 2008-2009 fiscal year. A summary of the proposed projects is as follows:
