AN ORDINANCE TO AMEND SECTION 2.(1) OF ORDINANCE NO. 8-00 (BOARD OF FEE APPEALS) SO AS TO ELIMINATE THE REQUIREMENT THAT THREE (3) OF THE FIVE (5) BOARD MEMBERS SHALL BE ATTORNEYS OF CERTIFIED PUBLIC ACCOUNTANTS.

WHEREAS, ON March 21, 2000, Horry County Council created the Board of Fee Appeals through the enactment of Ordinance No. 8-00; and

WHEREAS, Section 2.(1) of that ordinance required that, "Three (3) of the five (5) Board members shall be attorneys or certified public accountants." and

WHEREAS, both Council and the Business License/Hospitality Fee office agree that the work of the Board of Fee Appeals no longer has a mandatory need for attorneys and/or CPA's to serve on three of the five seats.

NOW, THEREFORE, by the power and authority granted to the Horry County Council by the Constitution of the State of South Carolina and the powers granted to the County by the General Assembly of the State, it is ordained and enacted that:

Section 2.(1) of Ordinance No. 8-00 is amended to the extent that the final sentence in this section shall be eliminated in its entirety. Henceforth, Section 2.(1) shall read as follows:

Section 2. THE BOARD OF FEE APPEALS:

(1) **Creation of the Board of Fee Appeals.** There is hereby established a Board of Fee Appeals to be composed of a chairperson and four other members. The Horry County Auditor and Horry County Treasurer shall serve as ex-officio members of the Board. The County Administrator shall appoint the chairman and four (4) members of the Board.

AND IT IS SO ORDAINED, ENACTED AND ORDERED.






