MOSQUITO SPRAYING SCHEDULE

For Monday, September 21, 2015

Horry County will begin mosquito spraying, weather permitting, in the following areas:

- Bucksport area

Aerial spraying will be conducted in the evening, usually between 7 p.m. and dusk, weather permitting.

The chemicals used for mosquito control spraying are approved by the EPA and pose minimal risk to humans or animals. Individuals with asthma or other respiratory illness may wish to stay indoors and close windows and doors during spraying. In addition, homegrown fruits and vegetables should be washed, scrubbed, and/or peeled before eating.

To help keep our honeybee population safe, beekeepers are urged to contact Horry County Mosquito & Spraying to identify the location of their colonies. In addition, citizens with concerns, complaints, or those requesting spraying in their area can also contact Horry County Mosquito & Spraying at 915-5174.

GLENN'S BAY ROAD WIDENING & INTERCHANGE PROJECT

- The outside westbound lane of Holmestown Road, between US 17 Bypass and Blue Jay Drive, will be closed from 6 a.m. until 7 p.m. each day starting Monday, September 21, 2015, until Friday, September 25, 2015.
- There will be a double lane closure with traffic shifts affecting east and westbound traffic on Holmestown Road from 7 p.m. until 6 a.m. each night starting Sunday, September 20, 2015, until Thursday, September 24, 2015. Traffic will need to follow the direction of the traffic control devices and proceed with caution.
- The east and westbound shoulders of Glenn's Bay Road between US 17 Business and Indian Oak Drive will be closed Friday, September 18, 2015, through Friday, September 25, 2015, for utility relocation (this closure is 24-hours a day).
- Sandy Lane will be closed Monday, September 21, 2015, through Thursday, September 24, 2015 for drainage work.
- There will be a lane shift on Glenn's Bay Road just east of Sandy Lane either Thursday, September 24, 2015, or Friday, September 25, 2015. This work will not hinder the flow of traffic. It will be shifting motorists over and channeling them using traffic cones.
- The northbound right shoulder of US Hwy 17 Bypass from the Church of the Resurrection to the intersection at Glenn's Bay Road will be closed from 7 a.m. until 7 p.m. each day starting Monday, September 21, 2015, until Friday, September 25, 2015.
