Hurricane Florence Disaster Recovery Update

Conway, SC (November 9, 2018)—Horry County Government is continuing to assist with the recovery effort following Hurricane Florence.

The mobile Disaster Recovery Center (DRC) Unit continues to operate in Horry County. The DRC is staffed by members of the Federal Emergency Management Agency (FEMA) and the United States Small Business Association (SBA) and open from 9:00 AM to 6:00 PM. Here is a list of centers operating in Horry County:

- Bucksport, James R. Frazier Community Center, open through November 10, 2018
- Little River, North Strand Recreation Center, open November 13 through November 15, 2018
- Socastee, South Strand Recreation Center, open November 16, 17, 19, and 20, 2018.

It is not too late to apply for assistance. The deadline to register for aid through FEMA – for uninsured or underinsured damage or losses due to Hurricane Florence – has been extended to 11:59 p.m., Wednesday, Dec. 5, 2018. Horry County encourages anyone who needs disaster recovery assistance to visit a Disaster Recovery Center to apply. Survivors can also call 800-621-3362 or 800-462-7585 (TTY) anytime from 7:00 AM to 10:00 PM local time seven days a week until further notice, or go online at DisasterAssistance.gov.

Horry County Animal Care Center to Hold Pet Vaccination Clinic

Conway, South Carolina – The Horry County Animal Care Center (HCACC) will hold a vaccination clinic, November 13, 2018, from 10 a.m. until 2 p.m. at the shelter located at 1923 Industrial Park Road in Conway. The following services will be offered:

- Distemper/Parvo \$10--must be at least 8-weeks old (*canine*)
- Bordetella \$10--must be at least 8-weeks old (*canine*)
- Rabies \$10--must be at least 4-months old (*canine & feline*)
- Microchip \$15--must be at least 8-weeks old (*canine & feline*)
- Rhinotracheitis/Calici \$10--must be at least 8-weeks old (*feline*)

Dogs and cats are both welcome; dogs must be on a hand-held leash and cats must be in a pet carrier.

The Animal Care Center also holds low-cost spay/neuter clinics, which are open to all residents of Horry County. The cost for cats is \$50 and dogs are \$80 (discounted fees are available for residents

To help homeless animals find loving homes, the HCACC offers discounted adoptions the first Friday and Saturday of each month. The discounted fee typically includes spaying/neutering, vaccines, heartworm or leukemia testing, heartworm and flea preventative, intestinal parasite treatment and microchipping. Qualifying new pet parents also get 30-days free pet health insurance and coupons from local pet businesses.

ROAD CONSTRUCTION UPDATE

Glenn's Bay Widening & Interchange Project

Traffic impacts weather permitting:

- There will be lane shifts on Glenn's Bay Road from Us 17 Business to US 17 Bypass Monday, November 12, 2018, through Friday, November 16, 2018, from 7 a.m. to 6 p.m. for driveway construction.
- There will be alternating lane closures in the east and westbound lanes of Glenn's Bay and Holmestown Road from Hopkins Circle to Blue Jay Drive Tuesday, November 13, 2018, through Thursday, November 15, 2018, from 7 p.m. to 6 a.m. for signal work.
- There will be lane closures on the southbound exit ramp on US 17 Bypass (the ramp will not be closed, only the lane in which the work is taking place will be impacted) Tuesday, November 13, 2018, through Thursday, November 15, 2018, from 7 p.m. to 6 a.m. for signal work.
- The inside south and northbound lane on US 17 Bypass will be closed between Sutter Drive and Glenn's Bay Road Thursday, November 15, 2018, from 7 p.m. to 6 a.m. for median work.
