## **ROAD CONSTRUCTION UPDATE**

### **Glenn's Bay Widening & Interchange Project**

*Traffic impacts weather permitting:*

- The north and southbound shoulders of US 17 Bypass from Queen's Harbor Boulevard to the Garden City Connector will be closed Monday, December 17, 2018, through Friday, December 21, 2018, from 7 a.m. to 6 p.m. for signage installation.
- There will be lane shifts on Glenn's Bay Road from US 17 Business to Blue Jay Drive Monday, December 17, 2018, through Friday, December 21, 2018, from 7 a.m. to 6 p.m. for pavement marking installation.

### **Carolina Bays Parkway (SC31) Extension Project**
