The Horry County Historic Preservation Commission met on Tuesday, February 27, 2023, at Horry County Government and Justice Center at 1301 2<sup>nd</sup> Avenue in Conway, SC. The following Commission members were present: Susan Platt, Joel Carter, Chelsea Anderson, Lesta Sue Hardee (arrived at 5:37 PM), Patricia Mallett, Jamie Thompkins, Heath Platt, and Bill Strydesky.

In accordance with the SCFOIA, notices of the public meeting were sent to the press (and other interested persons and organizations requesting notification) providing the agenda, date, time, and place of the meeting.

- **I.** Call to Order Chair Susan Platt called the meeting to order at approximately 5:30 pm. A quorum was present.
- II. Invocation Patricia Mallett delivered the Invocation and led the Pledge of Allegiance.
- III. Public Input None

**Approval of Minutes** – Chair Susan Platt asked the Commission members to review the minutes from the January 23, 2023 meeting. With no corrections or additions, Joel Carter made a motion to approve the minutes and Bill Strydesky seconded. The motion carried unanimously.

### IV. New Business

**Agritourism Permit 2019-05-001** - Lou Conklin gave an overview. Staff recommended approval. Chair Susan Platt asked what happened when an Agritourism Designation was removed from a parcel. Joel Carter stated they could no longer do business under the permit. Bill Strydesky made a motion to remove the Agritourism Designation and Chelsea Anderson seconded. The motion carried unanimously.

**High School Video Contest** – Lou Conklin gave an overview. Two (2) videos were over the 3-minute limit, so she asked for a decision from the Commission prior to viewing the videos. Joel Carter made a motion to include the videos before deciding and Jamie Thompkins seconded. The motion failed with Chelsea Anderson, Heath Platt, Susan Platt, Patricia Mallett, Lesta Sue Hardee, and Bill Strydesky voting no. Bill Strydesky made a motion to follow current rules which stated "no longer than three (3) minutes," and Patricia Mallett seconded. The motion carried with Joel Carter and Jamie Thompkins voting no. Chair Susan Platt asked staff to proceed with showing

the videos without the two disqualified videos and to change the verbiage in the video contest instructions which stated the video "may be disqualified" to "shall be disqualified."

### V. Commission Discussion

**Legacy Business Recognition** – Lesta Sue Hardee gave a brief update on the recognition of WLSC Radio in Loris. She stated the station had been in business since 1958, and they served cake and cider at the celebration. She was thankful that almost every Commission member attended the event.

Ms. Hardee stated she had funds to recognize four (4) businesses and she recommended the following: Fun Plaza Arcade; Jack Thompson Studio; Cash Grocery; and Hussey Motors. She would be contacting these businesses and looking for dates in April for the celebration.

Lou Conklin stated she had newspaper articles on the table for their review. The first article was about the unveiling of the historic marker in Loris and the second article regarding black churches being added to the local register.

Chelsea Anderson updated the Commission on another historic marker that is for the Waccamaw Indians. She will be contacting Carolyn Dillian to assist with sources for accurate information.

### VI. Announcements

**Little River Historic Marker** – Chair Susan Platt gave an overview. The marker should be completed in May, so the event may be planned for July. She would also like to get the community members involved.

### **Nominations for Historic Preservation Awards**

Lesta Sue Hardee nominated Becky Billingsley and Dianne DeVaughn Stokes. Joel Carter stated City of Myrtle Beach celebrates their history and Ms. Stokes hosts many of those celebrations. He wondered if any other Municipalities might have such programs. He will gather more information. Chair Platt nominated Mary Gowens for her work with the neighborhood services in Myrtle Beach, as well as Charlie's Place and the Colored School. Jamie Thompkins asked about the gentleman who redeveloped the Platt building on Main Street. Ms. Conklin stated he had not been back for final certification. Heath Platt nominated Friends of the Chapin Library for their Meet & Greet with approximately 5/6 long time residents that showed the history of Myrtle Beach from different aspects. Chair Susan Platt nominated Atlantic Beach Historical Committee for their Telling the Story Grant. Chelsea Anderson nominated Keith Edwards for his Facebook page. Bill Strydesky asked about Chief Hatcher, and Chair Susan Platt asked about Jamie Graham. Mr. Thompkins stated Mr. Edwards, Mr. Graham, and Chief Hatcher had been recognized. Pat Mallett nominated John Skeeter

in Atlantic Beach. Ms. Conklin stated she had these names listed, but formal nominations needed to be submitted on the appropriate forms or the nominations would not be considered.

Lou Conklin announced she had information at each table for the SC Historic Preservation Conference. Anyone wishing to attend should complete the form so she could get each one registered. Chair Platt asked that members share the information with local historical societies and others who may be interested in attending.

### **RECOMMENDATION:**

Review the ten properties individually based upon the Secretary of the Interior Standards for designation as historic, then consider adding to the Horry County Historic Property Register.

### **BACKGROUND:**

Horry County has recognized the need to preserve the County's local heritage as an irreplaceable asset through the creation of a list of designated individual properties, sites and landmarks, known as the Horry County Historic Property Register.

Horry County has established the prerequisites for a property to be added to the Register, those being, the Property:

- a. Has significant inherent character, interest, history, or value as part of the community or heritage of the community, state or nation; or
- b. Is the site of an event significant in history; or
- c. Is associated with a person or persons who contributed significantly to the culture and development of the community, state or nation; or
- d. Exemplifies the cultural, political, economic, social, ethnic or historic heritage of the community, state or nation; or

- e. Individually, or as a collection of resources, embodies distinguishing characteristics of a type, style, period or specimen in architecture or engineering; or
- f. Is the work of a designer whose work has influenced significantly the development of the community, state or nation; or
- g. Contains elements of design, detail, materials or craftsmanship which represent a significant innovation; or
- h. Is part of or related to a square or other distinctive element of community planning; or
- i. Represents an established and familiar visual feature of the neighborhood or community; or
- j. Has yielded, or may be likely to yield, information important in pre-history or history.

The Horry County Historic Preservation Commission (HPC) has been charged with the responsibility of identifying and recommending to County Council the addition of properties meeting the above standards to the Horry County Historic Property Register.

Each of the proposed sites must be a minimum of fifty (50) years old in addition to meeting other standards.

### **ANALYSIS:**

Letters were mailed to property owners in accordance with the zoning ordinance regarding the addition of the properties to the Historical Property Register.

### Rufus Davis Family Farm House

PIN # 190-08-02-0006 circa - 1960

This structure was built by Rufus and Marvin Davis sometime around 1960, according to Horry County records. Marvin recalls 5 or 6 neighbors helping to build the house. At the time the house was built, you did not need a qualified brick layer. Credit was used at the hardware store in Loris and then the bill paid after gathering tobacco. Marvin stated that he later re-did the bathroom because it was not built up to code. He also believes that this house is the oldest home in Bayboro.

This structure is built in the mid-century vernacular style using unadorned blocks as the dominant material. The structure is rectangular with a hipped roof and front gabled porch. Sometime later the porch was screened in. A carport sits at one end of the structure sharing the same roof as the house. A storage shed was constructed at the rear of the carport and this is separate from the house itself, but is also under the roof. The windows are original wood, with most being two over two, with decorative shutters. There is a block chimney on the rear of the house and a weather vane/lighting rod sits atop the structure.













The Horry County Library located in Conway, SC, has records showing in the year 1868 documents were filed proclaiming the Brown Chapel African Methodist Episcopal Church (AME) was a place of worship for the Negro people in the Bucksville Community. Prior to this time the congregation worship ed at the Hebron Church.

According to Horry County records, the current church was constructed around 1960. This building is the fourth one built for the congregation. Storms blew the other structures down. The first in 1893, the second in 1926 and the third in 1954. The last structure is built in the simple mid-century vernacular style, using one dominant material, constructed in simple geometric form and using concrete block with bricks adding some detailing around the windows. It is built in a cross gable configuration with unadorned porch railings and supports. The roof sits directly on the porch supports.

Old timers still call this church the Old Shell Church. It is very unique in that the baptismal fount was located outside next to an artisan well. The well is now dried up but still remains on the property. An iron fence has been placed around the baptismal, but was not there when the baptismal was in use.

The building was originally a rectangular one room structure with a front gable. Two porches were added sometime later, one on the front and the other to the side of the building. Inside the original beadboard covers the walls and ceiling, and the wood flooring is still present. Wood one over one windows are used in the original structure. At the rear of the structure, indoor bathrooms were added using beadboard on the walls and wood floors in the hallways, that match the original construction.

### St. John Church of God

According to Horry County records, this structure was built in 1965. The congregation purchased the blocks and a professional block layer laid the blocks. After the walls, roof, floor and windows were constructed, the benches from the old church were brought in and the congregation started to use the building, while continuing to work on the inside. A wood stove was the original heat system for the church. In 1975 the building was finally dedicated.

The structure is built in the simple mid-century vernacular style, using blocks as the dominant material and constructed using the simple geometric form of intersecting rectangles. While both of the roofs are gabled, they do not intersect with the side facing gable at the rear of the structure having a roof line lower than the front facing gable. An unadorned gabled portico expands the front of the building with columns and pilasters almost void of details. The roof sits on the columns without an entablature. The railing are made of round unadorned metal elements. The windows are original multi-paned sashes with wood mullions and a fan on top with a brick arch above. The doors are also multi-paned with wood mullions. Inside the original tile and wood remain.

### **Hemingway Chapel AME Church**



Church members believe the name came from the Hemingway Plantation. While the County records indicate a construction date of around 1960, church member Ms. Williams sets the date of construction around 1970. She recalls when she graduated in 1969 the old church was still in use. She left the area after graduating and when she came back in 1972, the new building had been constructed.

The structure is built in the simple mid-century vernacular style, constructed in simple geometric form and using one dominant material; concrete block that has been stuccoed over. It is built in a cross gable configuration. The sanctuary portion of the church features pointed arch-topped windows reminiscent of the Gothic Revival style. All other windows in the building are six over six. The front of this church is unique in that there is a vestibule to the building within what is usually the porch area. Doors to the church come off both sides of this vestibule and face to the sides of the church, not to the front. At one point in time a person could ring the church bells from inside this small vestibule. Originally the church was heated with a wood stove and there was an outhouse out back.

This frame building was constructed in 1875 by W. T. Goldfinch. Sunday school rooms were added in 1933 and the church was extensively remodeled and enlarged in the 1950's with work completed in 1957. Wood flooring, beadboard and wooden benches can still be seen inside. Transom windows are above the main door and six over six wood windows still remain.

Christian Monroe Holliday Douglas was born in Galivants Ferry, South Carolina into the fourth generation of the Holliday family. Christy Holliday Douglas, is the granddaughter of George J. Holliday, who converted much of the family's 9,000 acres of pines and swamps to tobacco fields, and eventually became the nation's largest tobacco grower.

Christy successfully lobbied to have the family farm and historic structures placed on the National Registry as a historic district, including infamous tobacco barns. There are a totally of 26 structures that are named in the district.

The family's country store, included in this historic district, originated in 1869. It is still open and serving the public. It is also the site of the biannual Galivants Ferry Stump meeting, the oldest Democratic Party rally in the country which will celebrate their 146th anniversary this year. Christy has been instrumental in the continuation of this historic biannual event and continues to play a large part in the success of this event.

Christy served for four years on the Horry County Historic Preservation Commission until leaving to care for her husband.

Christy Douglas is an amateur historian who has collected family stories of the Galivants Ferry region and culminated them into her book, Love notes to my children. Christy has been amassing photographs and stories that tell the history of Galivants Ferry through its people and her memories, compiling them into a book of love letters to her children: *The South I Knew*.

On July 10, 2019 the Loris Historical Society successfully closed on the purchase of the Historic State Theater.


Since then, the Society has worked diligently to raise monies for the restoration of the theater.




