





Public Information Meeting Format

The following Public Information Meeting will be informal. Maps of the road projects being considered will be on display and representatives from the RIDE 3 Sales Tax Commission, SCDOT, Horry County and others will be available to answer questions from the public.

Sales Tax Commission Overview/Mission

The RIDE 3 Sales Tax Commission is comprised of six members, three appointed by Horry County Council and three appointed by the cities as defined by state law.

This commission was tasked by Horry County Council to prepare a final list of road projects that will be funded by a 1% Sales Tax by May 17, 2016. Horry County Council will then have the option to move the final list to a vote by ordinance and to a referendum vote by the citizens of Horry County on the November 2016 General Election ballot. If passed by the voters, the 1% Sales Tax would go into effect May 1, 2017, and would be taxed on all retail sales, prepared food/beverages and accommodations. Groceries (unprepared food) would be exempt from the sales tax. The sales tax would remain in effect for eight years or April 30, 2025. The eight year projected revenues from the 1% Sales Tax are \$590 million.

Public Feedback

The RIDE 3 Sales Tax Commission encourages feedback from the public on the proposed road projects as well as other road projects to consider.
