**Horry County Board of Architectural Review
and Historical Preservation
January 15, 2013**

The Horry County Board of Architectural Review met on Tuesday, January 15, 2013, in Multi-purpose Room B of the Horry County Government and Justice Center at 1301 2nd Avenue in Conway, SC. The following Board members were present: Chairman Joel Carter, Ernestine Allen, William Long, Carolyn Dillian, and Bill Strydesky. Staff Present: Adam Emrick and Nancy Tindall.

In accordance with the SCFOIA, notices of the public meeting were sent to the press (and other interested persons and organizations requesting notification) providing the agenda, date, time, and place of the meeting. In accordance to the Horry County Ordinance a minimum of a twenty-one day notice was given.

Chairman Joel Carter called the meeting to order at approximately 2:34 PM, and Bill Long led the invocation.

Old Business

- A. **Horry County Register of Historic Places** – Mr. Emrick stated the count stands at 178 Properties. However, he will be advertising a public hearing in February for fifteen parcels which includes two Century Farm designated properties.

- iv. **Brochures** – There was discussion concerning publishing the brochures on the internet. The Board discussed publishing a Green Sea/Floyds brochure and updating the Socastee brochure. Mr. Strydesky suggested developing brochures online and asking for participation from the public. He thought Facebook was a good tool for this.
- v. **Top Priority of the Action Plan** – The Board members agreed the needed three more
