**Horry County Board of Architectural Review
and Historical Preservation
March 21, 2017**

The Horry County Board of Architectural Review met on Tuesday, March 21, 2017, in Multi-Purpose Room B of the Horry County Government and Justice Center at 1301 2nd Avenue in Conway, SC. The following Board members were present: Bill Strydesky, Sam Dusenbury, Joel Carter and Chris Clark. Staff present: Mary Catherine Hyman, Richard Hathcock and Susi Miller. Board members not present: Katie Clary, Christy Douglas and Jody Nyers.

In accordance with the SCFOIA, notices of the public meeting were sent to the press (and other interested persons and organizations requesting notification) providing the agenda, date, time, and place of the meeting. In accordance to the Horry County Ordinance a minimum of a twenty-one day notice was given.

I. Call to Order – Vice Chairman, Bill Strydesky called the meeting to order at approximately 2:30 PM.

II. Invocation & Pledge of Allegiance – Sam Dusenbury

III. Approval of Minutes – February 15, 2017 and February 21, 2017 – Sam Dusenbury made a motion to approve the minutes, Chris Clark seconded. The motion carried unanimously.

IV. New Business

- A. Horry County Local Historical Sites & Structures High School Video Contest
 - i. Reviewed Videos, Mary Catherine Hyman gave an overview of the contest rules and criteria. Viewed video submissions of CCU, Fat Harold's, Fun Plaza, Horry's Seafood Restaurant, Kingston Presbyterian Church Cemetery, Myrtle Beach State Park, Peaches Corner, Peanut Warehouse, Pine Lakes, Time Waits for No One, Upper Mill Plantation
 - ii. Determine Winning Videos. Mary Catherine Hyman tallied the video scoring sheets and the winners for this year were: 1st Upper Mill Plantation, 2nd Time Waits for No One, and 3rd Horry's Seafood Restaurant. Joel Carter made a motion to approve the results and Chris Clark seconded the motion. The motion carried unanimously.
